THE CHALLENGE. In addition, Emersion wanted to work toward compliance remediation in anticipation of the upcoming CMMC Level III requirements. TechSolve's cybersecurity team completed a cybersecurity assessment, testing, remediation, data classification, policy writing, and documentation of the entire organization's cybersecurity process in order to assist Emersion Design to be in compliance with the current DFARS language and report its cybersecurity compliance score, based on the Interim Rule, according to DFARS 252.204-7012 and the NIST 800-171 security framework. TechSolve additionally delivered cybersecurity and IT training in order to prepare them for future CMMC compliance. Topics in the training included secure data handling; insider threat; social engineering; email and social media; identity and access management; clean desk, clear screen; and Emersion cybersecurity and IT policies.
